Dear foster and kinship carers

I hope you all had a relaxing Easter break connecting with your family and friends online or by phone and enjoying some chocolate and Easter treats.

Changes to Term 2 learning

It seems everyone's talking about the recent announcement by [Education Queensland](#) that schools and community kindergartens will move to home-based learning for the first five weeks of Term 2.

From 20 April to 22 May, all children who are able to be supervised at home are to stay at home for their schooling. However, Education Queensland also advises children who currently receive services from Child Safety or who are in out-of-home care, can attend school, early childhood education and care, and outside school hours care services. Children will be supervised and will participate in the same learning program as children who are learning at home.

Decisions about a child's attendance at school, early childhood education and care, or outside school hours care service need to be made on a case-by-case basis, and in accordance with the child's case plan. Please contact your child safety officer to talk through the options for children in your household. You can also contact your school, early childhood education and care, and outside school hours care service to discuss further.

If a decision is made to keep the children in your care at home the [learning@home](#) site provides a range of additional curriculum resources, to those provided by your school, and provides [advice for carers around preparing for learning at home](#).

Support for children with disability

If you're caring for children with disability, did you know that the NDIS has partnered with supermarkets so that families and carers can get help with grocery shopping?

Rather than having to go to the shops, food and other items can be bought online and delivered to your home. NDIS participants will be provided with a code to shop online at Woolworths, Coles, IGA and Foodworks.
